1. 歷史開箱：「敦煌藝術的隋唐歷史解碼」(下稱「活動」)是為教育局已註冊本地學校而設，學校須按教育局指引安排教職員到場，照顧學生並維持秩序。
2. 費用全免，所有申請將按先到先得的原則處理。申請人請於辦公時間內（星期一至五：上午 9 時 30 分至下午 12 時 45 分及下午 2 時至 5 時 30 分）致電 2812 7389 與職員預約，然後將填妥的申請表以電郵方式 (ccpo-prog@lcsd.gov.hk) 或傳真 (2812 7400) 遞交至康樂及文化事務署弘揚中華文化辦公室（下稱「本辦公室」）(電郵標題請註明「申請歷史開箱 — 敦煌」)。
3. 凡申請者須於建議活動日期前最少一個月前遞交申請表。若申請人未能如期遞交申請表，其預約申請將自動取消。
4. 申請如獲批准，本辦公室將在審批後七個工作天內發出書面通知作實。有關活動安排，弘揚中華文化辦公室保留最終決定權。

1. Local schools registered with the Education Bureau may apply for Unveiling History - 'Decoding the Sui-Tang History Through Dunhuang Art' (the Activity) on a group basis. Schools should assign sufficient staff support according to the guidelines of Education Bureau to take care of the students.
2. Free of charge. Application is on a first-come, first-served basis. Please contact 2812 7389 for advance booking during office hours (Mon - Fri: 9:30am-12:45pm & 2:00pm-5:30pm) and then email (ccpo-prog@lcsd.gov.hk) or fax (2812 7400) the completed application form to the Chinese Culture Promotion Office (CCPO) (Please mark 'Application for Unveiling History - Dunhuang').
3. Applicants are requested to submit the completed form at least one month in advance. Incomplete Application form will not be processed.
4. Successful application will be confirmed in writing within 7 working days. Chinese Culture Promotion Office reserves the right of final decision on the arrangements and results of the application of the programme.

Activity Arrangements
